

Miami Grit Classic 2025 Foreign Clubs Registration Instructions



Dear Participants,

We extend our heartfelt gratitude for your presence and participation in the 2025 Miami Grit Classic. It is an immense honor to host representatives from various countries, as it embodies our vision of fostering a vibrant community and celebrating diverse cultures. Such events exemplify the true essence of sports, transcending boundaries to create meaningful connections and enriching experiences for all involved.

To facilitate the registration process for foreign athletes and coaches we have outlined the following instructions:

- 1. Submission of Application and Fees: All non-U.S. citizens residing outside of the United States who intend to participate in a Foreign Sanction event as athletes, coaches, or judges are required to submit the Foreign Athletes, Coaches, and Judges application along with the applicable fee of \$50 (USD) per participant. This fee is solely for insurance purposes and does not include any additional membership benefits. Applications must be submitted no later than forty-five (45) days before the meet or competition. Please ensure that the application is filled out completely for expedited processing. Attached to this letter, you will find the application form that must be completed and each coach and gymnast must be listed there. Once filled out, please send the form to the following email address: membership@usagym.org.
- 2. **Online Payment:** Upon receipt of your application, you will receive instructions for online payment via email.
- 3. **Processing and Registration:** Upon receiving your completed form, the USA Gymnastics (USAG) team will process your application and register you in the meet reservation system.
- 4. **Invoice:** Subsequently, you will receive an invoice detailing the total registration cost for the competition. Please note that this payment is separate from any previous payments made to the USAG by your club.

5. **Timely Registration:** We emphasize the importance of timely registration, as the processing of applications may take longer than 45 days. Ensuring timely submission will expedite the process and secure your participation in the event.

2024/2025 USA GYMNASTICS FOREIGN ATHLETES, COACHES & JUDGES

The Foreign Athletes, Coaches and Judges application and applicable fees must be submitted for anyone who resides outside of the United States and intends to participate in a Foreign Sanction event as an athlete, coach or judge. The cost for non-U.S. athletes, coaches and judges is \$60 (USD) per participant. The membership cost covers insurance only and foreign members will not receive any other membership benefit.

Application must be submitted no later than forty-five (45) days before the meet or competition. All USA Gymnastics inter-club competitions follow FIG guidelines, and require federation to federation approval before foreign sanctioning and foreign participant memberships are processed. Memberships will be given only to those individuals that are registered for foreign sanctioned events. This form must be filled out completely for processing.

Foreign Athletes, Coaches and Judges are eligible to participate in Foreign Sanctioned events only and are not permitted to participate in Domestic Sanctioned events. Individuals applying for a USA Gymnastics Foreign athlete membership may not also hold a domestic athlete membership during the same competitive season (August 1-July 31.)
